1. Overview of changes

These updates were deployed to DATIM on January 4, 2021 in preparation for FY21 Q1 Data MER Results and COP21/FY22 MER Target data entry period opening on January 6, 2021. This update includes MER FY21 Results and COP21/FY22 Targets data entry form updates (details listed below).

- New Indicators There are no new indicators for MER 2.5
- Retired Indicator One MER indicator has been removed for FY21 Data Entry:
 - HRH_CURR: Moving forward, HRH data will be collected via the HRH inventory.
- **Updated Indicators** Many indicators underwent modifications in the form of new disaggregates, changes to existing disaggregates, reporting frequency, etc. Further details on specific changes for each indicator can be found below.
- Central Support Update Starting in FY21, PEPFAR Central Support will be collected as third support type, separate from DSD and TA. TX_PLVS will be added to the list of Central Support indicators. Central Support data will continue to be reported annually.
